MPI Approval & Relevance to CellarGroup Products

According to the Approved Maintenance Compounds (Non-Dairy) Manual, published by MPI on 7 October 2019:

- 1. "This manual only applies to maintenance compounds used by operators processing **non-dairy animal products** who are operating under the **Animal Products Act** (APA) regime."
- 2. "Operators processing food under the Food Act, are not required to use approved maintenance compounds / chemicals. These operators must determine that the maintenance compounds / chemicals that they use will not adversely affect the food being processed. Some operators voluntarily elect to use APA (Non-dairy) approvals to assist with determining the acceptability of compounds."
